### Please note:

**Sale or Display of offensive or nuisance items-** The Society reserves the right to ban the display or sale of any items deemed unsuitable. Such items include large water pistols, cap guns, any other type of gun which fires a projectile, pop downs (throw downs), knives, martial art nunchucks, offensive T shirts, and any equipment associated with illicit drugs.

Any Stall Holder found to be in breach of these regulations may be closed, or instructed to remove the unacceptable items from sale.

**OH & S Requirements-** All Stall Holders have a 'Duty of Care' to avoid exposing themselves and other people to situations that could cause injury and harm.

Food and Show Bag Vendors will be provided with a summary of Health requirements to be observed, and must expect at least one visit from the City Environmental Officer during the Show. Similarly, anyone using gas cylinders will be required to comply with current regulations.

**Use of Electricity-** Site Applications include the use of Power, but should not expect to have more than one 15amp outlet available during the Show. All Power leads must carry inspection tags, not lie unprotected across public thoroughfares, and under no circumstances are power outlets to be interfered with. Officers of the Victorian Workcover Authority inspect the Warrnambool Show each year.

**Staff passes** – 2 per site are provided, extra passes must be purchased at \$5 each.

**General Information-** Stall Holders are required to maintain their site in a neat and tidy state.

Cartons and other recyclable materials are to be flattened and tied up and placed next to rubbish bins.
